■■ Digital Strategy

The Council adopted its conclusions on shaping the digital future of the Union, addressing a wide range of issues related to the implementation of the European digital strategy. The areas covered by the conclusions go from data economy, platforms, artificial intelligence to connectivity, digital value chains and eHealth. In particular, the Council calls on the Commission to present concrete proposals on data governance and to encourage the development of common European data spaces for strategic sectors; encourages the Commission to take concrete steps to facilitate the emergence of new data-driven ecosystems. It also calls on the Commission to deliver a coherent framework for cloud services and for artificial intelligence.

Aviation Emissions

The Council adopted its position on the reference period to be used for measuring the growth of CO2 emissions in international aviation, to take account of the consequences of the coronavirus crisis. The CORSIA (Carbon Offsetting and Reduction Scheme for International Aviation) baseline will be discussed by the ICAO Council during its next session from 8 to 26 June. The text will be published in the EU Official Journal.

■ RAPEX Weekly Report

The EC published its weekly report for all dangerous consumer products, with the exception of food, pharmaceutical and medical devices.

■■ Sustainable Finance

In particular, the Commission is consulting on the following aspects: (i) obligation for mutual funds to advise clients on social & environmental aspects; (ii) obligation on investment funds to advise clients; (iii) obligation for insurance firms & brokers to advise clients; (iv) obligation for (re)insurance companies to advise clients on social & environmental aspects; (v) obligation for investment firms do advise clients; (vi) obligation for alternative investment funds to advice clients. ■■ Foreign Subsidies

The College of Commissioners shall adopt on 17 June a White Paper on Foreign Subsidies.

A public consultation on the Environmental and Energy State Aid Guidelines shall be launched in the first half of next year.

■ Brexit

The EU chief negotiator affirmed that the Union is ready to find the necessary compromises to break the impasse but warned the UK that it will not accept a "cherry-picking approach" and proposed weekly

meetings in order to speed the talks. On 15 June the President of the Commission and UK Prime Minister will have a conference call to discuss the progress in the negotiations and perhaps extend the current transition period, which ends on 31 December this year.

Privacy and Electronic Communications

The Presidency of the Council released a progress report on the proposal concerning the respect for private life and the protection of personal data in electronic communications, which will repeal Directive 2002/58/EC.
