






Litigation

Focus: advising on incidents related supply chains



Fact-finding, particularly:

- Gathering and evaluating relevant data (e.g. documents, emails, chats, cloud)
- Where appropriate, using artificial intelligence to efficiently analyse large amounts of data
- Conducting interviews
- Investigating on-site

Advising on legal issues, particularly:

- Data protection law, e.g. data processing
- Labour law, e.g. involving the works council
- Continuously checking for any duties of public disclosure
- Assessing the situation according to local law and bringing in international "best friend" law firms (Lex-Mundi) where necessary


Providing strategic support, particularly




